#### **ENTRY FORM DEADLINE**

#### **TEAMS**

- There will be five divisions: Adults, Senior (grades 9 and 12), Intermediate (grades 6-8), Junior (grades 3-5) and pee wee (grades K-2). Grades as of Jan 1, 2023
- Teams will consist of four members (2- Females and 2- Males) –  
(if needed the team may consist of 4 - females)
- Each member may only participate on ONE team.

#### **DRESS CODE**

- a. Closed-toe shoes
- b. Pants or shorts
- c. T-shirt (no muscle shirts, spaghetti straps, tank tops or halter tops)
